Bid security amount of sealed quotation should be as mentioned on the table below for each quotation and the eligible bidder should submit the original voucher with bid document or submit equivalent bank guarantee from Commercial Bank or Financial Institution eligible to issue Bank Guarantee as per prevailing Law having validity period of 75 days for sealed bid in the following Security deposit (Dharauti) account as specified below.

5. Sealed quotation must be submitted to the Administration section, Bhanu Municipality, Tanahun by hand/courier before 12:00 PM on 2077/09/27 Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 PM, 2077/09/27 at the Bhanu Municipality, Store section, Tanahun.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
8. The Employer reserves the right to accept or reject any or all the bids without assigning reason, whatsoever. Any intimidation, collusion and curtailing during bidding process shall be punishable by law. The quantities specified in BOQ can be modified as per requirement.
