4. Pre-bid meeting shall be held at Bhanu Municipality Office at **12:00 on 18th Feb 2021**
Bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egg on or before **12:00 on 25th Feb. 2021**. Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 on 25th Feb. 2021**, at the office of **Bhanu Municipality**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. **2,20,000.00 (Two Lakh Twenty Thousand)** which shall be valid for 30 days beyond the validity period of the bid i. e. **26th June 2021**.
6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid



submission.

7. Bidders are advised to visit site and assess the actual site condition before submitting their bids.
8. A firm may submit the bid only once either independently or in a joint venture with another firm in electronic bid. To facilitate contract administration, the number of J/V partner is limited to three for electronic bid.
9. Any amendment in the tender notice shall be published in e-procurement section of PPMO, www.bolpatra.gov.np/egp and in National daily Newspaper.
10. Bidders are required to submit original documents within seven days from bid opening.
11. The eligible bidders must attach the ***Bid Security on the format given in section IV***
12. Name of the Office and the Contract No. Should be clearly mentioned in the Bid Bond Guarantee, otherwise the Bid will be treated Non Responsive.
13. The Employer reserves the right to accept or reject, wholly or partly, any or all the bids without assigning any reason, whatsoever.
